Sub: Review of membership of Government Accounting Standards Advisory Board (GASAB).

GASAB was established in the year 2002 by the Comptroller and Auditor General of India (CAG) with the assistance of Ministry of Finance, Government of India vide notification dated 12th August 2002.

- Over the years, the constitution of GASAB has been reviewed with reference to the nomination of States which are selected on rotation basis. However, a complete review of the Board has not been done vis-à-vis the objectives of GASAB and other responsibilities towards improving the standards of Governmental Accounting and Financial Reporting and enhance accountability mechanisms.
- With this intent, a detailed review of the GASAB Board was carried out, recently and the CAG of India has approved the re-constituted Board, as follows to take effect from the date of approval (27th August 2021):

  - 3. Member (Finance) Telecom Commission, Department of Telecom.
  - 4. Secretary, Department of Post
  - 5. Controller General of Defence Accounts
  - 6. Controller General of Accounts
  - 7. Additional /Joint Secretary (Budget,) MoF, GoI
  - 8. Deputy Governor, Reserve Bank of India or his nominee
  - 9. Additional Deputy CAG, GASAB
  - 10-13. Principal Secretaries (Finance) of four States by rotation
  - 14. President, Institute of Chartered Accountants of India (ICAI) or his nominee
  - 15. Director General /Principal Director (Government Accounts), Office of the CAG as Member Secretary.
- 4. This issues with the approval of Deputy CAG & Chairperson, GASAB.
